BYLAW NO 04-2024

A BYLAW TO REQUIRE CRIMINAL RECORD CHECKS WITH NOMINATION FORMS

The Council of the Rural Municipality of Blaine Lake #434 in the Province of Saskatchewan enacts as follows:

- 1. Every candidate for municipal office shall obtain a criminal record check at their own expense.
- 2. The criminal record check includes:
 - a) Form 5.1 prescribed in *The Municipalities Regulations*; and
 - b) The document provided by the police service.
- 3. The criminal record check shall be included with, and form part of the nomination form submitted by the candidate for municipal office.

4. This bylaw shall come into effect on August 20, 2024.
