Bylaw 01-2025

A Bylaw for Encroachment on Roads

Farming road allowances of engineered, constructed and graded roads are strictly prohibited. An individual or a corporation causing damage or altering a municipal right of way, by an agricultural operation, will be responsible for all costs of remediation deemed necessary by the municipality. Farming the shoulder of a road and slide slope to the base of the ditch, and the destruction of the grass thereon is strictly prohibited.

A Developing Permit (approval) is required for <u>ALL</u> development and improvement within the RM. Allow 3-5 weeks for processing. Do not start your project until you have the permit approved by Council. All permit forms are available on our website and at the office. If you have any questions, please contact the office. Submit your request and the paperwork pertaining to the permit to the office the Thursday prior to a Council Meeting.

Gravel Requests

Any or All Fire Department Equipment Responding \$50.00/HR

All Members attending or on Standby. Standby Charge is max (one) 1 hr.

\$150.00-\$300.00/Load

Private Water Tanker Service based on size and gallons supplied.

\$500.00 Flat Fee

Call dispatched members and units responding. Stand down or cancelled request for service.

\$0-\$500.00/Occurrence

False/Unnecessary/Unwarranted Alarms. First Alarm Response is Free-No Charge. Any alarm response after first one is \$500.00/Occurrence.
\$200.00/HR

Gratuities will be offered to owners of Heavy Equipment, if required.
