

**A BYLAW TO REQUIRE CRIMINAL RECORD CHECKS WITH  
NOMINATION FORMS**

The Council of the Rural Municipality of Blaine Lake #434 in the Province of Saskatchewan enacts as follows:

1. Every candidate for municipal office shall obtain a criminal record check at their own expense.
2. The criminal record check<sup>1</sup> shall be included with and form part of the nomination form submitted by the candidate for municipal office.


