

**A BYLAW TO REQUIRE CRIMINAL RECORD CHECKS WITH
NOMINATION FORMS**

The Council of the Rural Municipality of Blaine Lake #434 in the
Province of Saskatchewan enacts as follows:

1. Every candidate for municipal office shall obtain a criminal
record check at their own expense.
2. The criminal record check¹ shall be included with and form
part of the nomination form submitted by the candidate for
municipal office.

¹ The criminal record check must be in the form prescribed by the minister (Form B.1 in The Municipalities Regulations) and it will include the form issued by the RCMP or local police department.


